COMMON GROUND & ENTRANCE MAINTENANCE

- We have Heritage Lawn and Landscape as our common ground service for 2019+
- By switching from Partel's (\$17,674 in 2018) to Heritage (\$10,611 in 2019) we've realized significant savings.
- Any common ground issues?

ROADWAY MAINTENANCE - TED STANFIELD

- Ted has been working with Councilman Mike Elam identifying dangerous intersections where we need stop
 signs, etc. like Saddlebrook Dr. at Harness Dr and Harness at Clydesdale, especially with the upcoming
 completion of the 364 interchange. At both intersections, drivers fail to slow down and yield to the right of
 way with the possibility of a stop sign on Saddlebrook dr. and on Harness Dr. at Clydesdale. Speeding is also
 an issue with school bus stopping issues.
 - o MOTION TO ACCEPT Make Auburn Hills & Gutermuth Rd. or Clydesdale Drive & Gutermuth a fourway stop; vote favorable to Auburn Hills.

- o 2ND All in favor: motion passed
- "Prevent Theft" signs to be moved permanently to underneath the no soliciting signs at entrances.
- St. Charles County Police are making more drive through's than they used to. Ted stays on them to make us a priority.

TREES OVER ROADWAYS

- 14-foot clearance required by County
- Think School Bus, Fire, Delivery and Trash Services
- Cuivre River Lights obstructed/damaged

- Language for Vehicles
 - o Section 8 of Article IX of Indentures replaced
- Trash & Recycling
 - Section 14 added to Article V of Indentures (see HOA Presentation)
 - Republic Services' current quarterly rates for HOA are:

Trash*: \$31.35 (10.45/mo)
 Recycle: \$24.60 (8.20/mo)
 Yard Waste: \$25.47 (8.49/mo)

*Trash is required the other two services are optional.
